SIMply wonderful

[•] he International Correspondence L Chess Federation has created a new title to identify those players who are midway between an International Correspondence Master and a Correspondence Grandmaster. The title is bestowed on those players who have achieved two or more Senior International Master (SIM) norms in a mini-mum of 24 games. The SIM norm (linked to ratings) requires the player to play at 2500 strength in appropriate tournaments. This year the recipients of the SIM title were Tim Runting, Australia; Michael Freeman, New Zealand; Kiyotaka Sakai, Japan; Junior Tay, Singapore; and an explosion of US players: Jason Bokar, Jon Edwards, John Knudsen, Robin Smith, Jerry Weisskohl, and Max Zavanelli. **Congratulations**, gentlemen!

GAME OF THE MONTH

The US team has fought hard in the 13th Olympiad. At the moment there are only three games left for the USA and qualification (or lack of) depends upon the outcome of those three games. SIM Jon Edwards won the fourth of the four games being played to qualify. Here is his final contribution to the team's push toward the finish.
